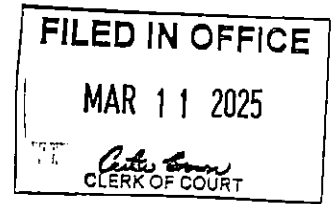

TO ALL PARTIES AND COUNSEL OF RECORD:

In compliance with Section 7.1 and 7.2 of the Uniform Court Rules of the Superior Courts of the State of Georgia, you are hereby ordered to prepare and submit a proposed, consolidated Pre-Trial Order to Judge Don W. Thompson at cindycombs1544@gmail.com. **BY EMAIL ONLY, (FACSIMILE WILL NOT BE ACCEPTED)**, by **April 11, 2025 at 4:00 P.M.** in the following cases. Mailing said order on or before said date shall not constitute compliance with this order. **No cases will be continued except for legal cause under §9-10-150 et. Seq.(Art. 7) O.C.G.A.**

Violation of this order will result in the imposition of appropriate sanctions. The Uniform Court Rules of the Superior Courts of the State of Georgia are hereby made a part of this order.

Those cases that have been pre-tried previously, and in which a consolidated pre-trial order has been signed by the Court, will not be pre-tried unless counsel deems it necessary.

If any cases have been settled, file the necessary order of final disposition with a copy to Judge Thompson.

If the parties are unable to file a consolidated pre-trial order, it will be necessary to have an oral pre-trial hearing to prepare a consolidated pre-trial order and trial counsel will be expected to attend that oral pre-trial hearing.

All pending motions should be disposed of by the time the consolidated pre-trial order is due, or an oral pre-trial hearing shall be scheduled, so that all pending motions can be disposed of before the case is set on the trial calendar.

If an oral pre-trial is requested, the parties shall call the office of Judge Thompson 706-638-1650 to schedule same. Calendar information will be posted at www.lmjc.net.

A final jury trial calendar will be prepared and furnished counsel of record upon completion of pre-trial hearings. Cases will be set for trial during the week of **May 12, 2025**.
